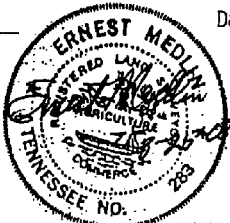

WHEREAS, it is the desire of the Management of the Cloister at St. Henry to correct that part of the Master Deed identified as Exhibit "B" for future reference;

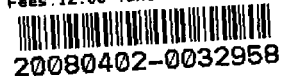
