Onsite Manager Valerie Williams was present on behalf of Ghertner & Company along with fourteen homeowners. Ted Thaler was absent.

Board President Lenys Biga called the meeting to order and asked for approval of the minutes for the November 6th board meeting. They were approved. Then the minutes for the November 13th workshop were approved.

In other words, they can connect or disconnect the Cloister-sponsored TV service and make changes to any extras you might wish to add including Internet, premium channels, and/or phone service.

Their office hours are 10 a.m. to 7 p.m. Monday-Saturday and 12-5 p.m. on Sunday. You can also call 800-934-6489. It is helpful if you have picture ID when coming to the office. The 855 phone # used previously is no longer valid.

Service supplied by the Cloister is called a "Bulk Account," and the account number is 8396 51 173. But employees can also access your account by address or phone number.

JOANN EDMUNDS 408 Siena Drive

Joann moved to the Cloister in September of 2020 from her home in Brentwood where she had lived for 35 years. She was married to Lewis "Lea" Edmunds for 45 years until his death in 2019. Joann's realtor knew she wanted to downsize, and lucky for her—and us-she matched Joann up with her future home at the Cloister.

"The Cloister has been a total blessing...a true community with the most wonderful friends and neighbors," Joann said. She enjoys participating in the monthly potluck dinners as well as serving on the Good Neighbors Committee and the Bible Reading Group which meets twice a month.



She was born and reared in western New York, not far from Buffalo and Niagara Falls, one of six siblings. She graduated from Erie Community College in 1990 and then moved to Rochester. Joann's early work career began at Eastman Kodak Company in Rochester, NY.

Joann met the love of her life, Lea, in 1974. He was an IT consultant for IBM and then Xerox Corporation. In the early years of her marriage, Joann remembers a famous blizzard in 1977 during which they were literally buried under several feet of snow for over a week! So when Lea was offered a Data Center Manager position in Baton Rouge, LA, he and Joann did not have to think twice about moving away from snow country!

During the eight years in Baton Rouge, Joann worked for American Bank as a secretary to the Vice President of Operations and then for the Vice President of Marketing and Public Relations.

In 1985, Lea's company was acquired by Service Merchandise. The company moved Joann and Lea to Nashville in August, 1985. Little did Joann know that Nashville would become her home for the next 40 years. She went on to have a long career with Hospital Corporation of America and Tri-Star Centennial Medical Center for a combined total of 28 years, until she retired in 2015.

Her most treasured years were those spent with her husband as his caregiver until his death in 2019.

Joann is a member of Our Savior Lutheran Church and Academy on Franklin Road in Oak Hill. She is active in many outreach ministries supported by her church family. Her strong faith has helped her tremendously in her "golden years" at the Cloister.
